**MEMBERSHIP AGREEMENT, WAIVER AND RELEASE OF LIABILITY**

1. Membership in the Charter Oak Figure Skating Club Inc. and participation in COFSC activities is a privilege and that my membership may be revoked in accordance with procedures established in the COFSC by-laws.

These pictures will not be used for commercial purposes and individuals will not be further identified without permission. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless COFSC, Inc., its officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and leasers of premises used to conduct the event ("Releasees"), with respect to any and all injury, disability, death, or loss of damage to person or property, even if arising from the negligence of the releasees or otherwise.
